In 2022, over 3,000 educators and students participated in PLATO's online and in-person events, workshops, and classes. Over 45 Seattle public school classrooms participated in regular philosophy sessions over the school year. More than 100,000 people visited our new resource-rich website. Our Philosopher-in-Residence Program expanded nationally and is now operating in three new high schools, and creative new high school and middle school offerings attracted students and teachers across the country and internationally.
